Brutal Truths About Going Solar

Not all sunshine and rainbows though. Roof condition matters more than orientation - we've seen 30+ year old roofs handle panels fine with proper assessment. Maintenance? It's not "set and forget." Dusty panels in Arizona farms lose up to 25% efficiency until cleaned.

But here's the bottom line: With new flexible financing models and proven ROI timelines under 5 years, delaying solar adoption might soon count as corporate negligence. The question isn't "Can we afford solar?" but "Can we afford NOT to?"
